Use the headings below, in the order that they appear, to label the narrative. The bulleted items are examples of what could be included in the narrative.

### A. Professional Accomplishments

Include organizations where the nominee currently works and has previously worked. Detail important dates, titles and responsibilities.

Additional information could include:

- Significant professional accomplishments
- Licenses, degrees, areas of professional expertise
- Honors and awards (list dates, etc.)
- Special skills and abilities

### B. Leadership

Include organizational successes and obstacles the nominee has overcome, professional creativity and innovation.

### C. Vision

Include entrepreneurial activities and initiatives and/or business growth.

### D. Community Service

Include past and present active involvement in community organizations where the nominee has made a significant impact.

Additional information could include:

- Nature of involvement
- Honors and awards
- Milestones and/or significant accomplishments on behalf of community organizations
